St Petersburg College is the regional training center for 13 separate law enforcement agencies and numerous federal agencies. This "simulation city, comprised of numerous faux and limited penetration structures, will allow officers to respond to calls for service in a realistic and immersive setting. Officers will practically apply classroom skills involving de-escalation techniques, officer safety, school and student active shooter practices and numerous other law enforcement techniques to provide a safe community environment consistent with community standards. Additionally, this project will include Fire and EMS personnel.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The proposed "Simulation City " will be the only of it's type in Florida and designed to place law enforcement, Fire, and EMS professionals in a realistic and immersive environment. Faced with a realistic re-creation of the community they will be working in, instructors can create scenarios designed to make students think through those behaviors that are intended to prevent escalation of conflicts and align agency cooperation for the improved physical and mental outcome of the citizen subject. People may become committed to behaviors that tend to escalate conflict, so specific measures must be taken to avoid such escalation. This facility will enhance participant awareness regarding community expectations towards de-escalation techniques, diversity awareness, proper use of force, responder awareness, and quality health care.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The St Petersburg College Public Safety Training Center provides the initial academy training for approximately 250 law enforcement and correctional officers, 100 Firefighters, and 200 EMS professionals. Additionally, this center provides specialized training for 3,000 federal, state, and local public safety professionals. Training center coordinators are currently developing curriculum that will provide additional training opportunities for public safety professionals in new techniques associated with de-escalation techniques, communication, critical thinking, responder safety, and access to quality health care.

This project serves students from across the State through higher education training programs. Public and private agencies rely on our graduates to meet current needs and support economic mobility with their organizations and communities. The planned renovations will address student access to enhanced courses and equipment as well as techniques that are aligned with evidence-based best practices in policing, fire science, and emergency medicine.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Florida students and their families who are either interested in a public safety career and/or who are currently serving with an agency. There were 3,300 students enrolled at St Petersburg College of Public Safety last year and approximately 45,000 students served by the college in the 2018-2019 academic year.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Public safety professionals will learn safe and proper responses to incidents and the proper use of force escalation and de-escalation techniques within diverse populations. This will result in less incidents of civil unrest as well as measured reductions in injuries to first repsonders and the public.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

All contracts have performance requirements and penalties that protect the state's and the public's investment. No additional penalties are needed for this project.
