The Town of Bay Harbor Islands is seeking funding to upgrade approximately 200 l.f. +/- of 15" VCP sanitary sewer main to 18" PVC C-900 to accommodate a new private development. The private development is upsizing the existing 15" VCP sanitary sewer main crossing their property to 18" PVC C-900. Because of this, at the terminating manhole of their project, the Town must upsize the outflow pipe, from the terminating manhole to the Town's main sanitary lift station, to the same size (18") to meet DERM requirements.
