4. Project/Program Description

In answer to the FLDOE mandate for trafficking prevention for all students, KidSafe transformed its ten-year old, proven child safety curriculum to help school districts easily meet the mandate. With one powerful lesson per grades K - 5, children learn safety basics that empower them with self-advocacy skills, a clear safety language, body boundaries, and where to go when they need help. Filled with fun, confidence-building activities and 3D animation, this education ensures students receive consistent, scaffolded empowerment skills from K through fifth, preparing them for the more advanced trafficking prevention education they will receive in middle and high school. Our lessons are specifically written to teach children to understand what "healthy feels like", proper relationships, and their right to stay safe.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Completion of a child trafficking and exploitation prevention program delivered to students throughout Florida, grades K through 5. The lessons will include animated shorts, suggested activities and lesson plan for teachers. This education will fulfill for districts the FLDOE trafficking education mandate, and will empower children with essential safety skills, help them understand how to get help, and prepare them for more complex trafficking and safety/mental health education they will be receiving throughout middle and high school.

b. What activities and services will be provided to meet the intended purpose of these funds?

Program will be completed, then service provided for first year to all elementary school districts and individual elementary schools in Florida. All elementary educators will be able to access the lessons, videos, and scripts to provide students with the mandated education.

c. What direct services will be provided to citizens by the appropriation project?



Florida elementary schools will be provided Stay KidSafe! curriculum, access to videos and lesson plans and teacher suggested instruction, to teach elementary-age students personal safety, and prevent human trafficking and exploitation. Parents will be able to obtain information on website on what their children are learning, and further activities to keep their kids safe.

d. Who is the target population served by this project? How many individuals are expected to be served?

All Florida elementary school children, grades Kindergarten through 5th. The program can educate all (approx. 3,000,000 students) in the state of Florida.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Empowered children become powerful adults. One in four girls and one in six boys will report being abused by the age of 18. Many more children do not report, because they do not know how, and have not been taught an empowered voice in their own safety. Studies show abused children are 2 times more likely to become trafficked. The outcome of this project is healthier children-both mentally and physically, stronger families and safer communities, and the State of Florida having a unified language of safety taught to their children, sending the message that their safety is above all else.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?
