12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

1) Continue to support federal, state and local efforts in increasing family stability and decrease involvement in government systems by assisting families in distress; 2) Train Community Response Teams (CERT) and establish a communication network to increase the emergency response capacity of the Miami-Dade Emergency Management Department in times of disaster; 3) Expand the service area and locations to Broward, Monroe, Lee, Collier, Charlotte, Hendry, Leon and Glades counties; 4) Continue to provide ACCESS and vocational rehabilitation services; 5) Add additional resources to include mental health services.

b. What activities and services will be provided to meet the intended purpose of these funds?

The activities and services will include providing food, clothing and supplies at our service locations; providing food, clothing, supplies and emotional/spiritual support to referrals received from our increasing number of partners with memorandums of understanding; the development of a communication network for our volunteers; CERT training for emergency situations; volunteer training; special events that support these services; assisting the Emergency Management Department during disasters; and providing additional resources such as ACCESS, health services and job placement.

c. What direct services will be provided to citizens by the appropriation project?

Families, children, elderly, veterans and others in need will be provided with goods, clothing, supplies and services, including emotional/spiritual support in times of distress and/or disaster. Specially trained volunteers will be available to assist government entities in times of disaster. Mental health screenings, and job training and placement.

d. Who is the target population served by this project? How many individuals are expected to be served?



The target population is families and individuals that are experiencing hardships in times of distress including, but not limited to, elderly; adults; disabled; veterans; abused, abandoned and neglected children; and victims of crimes The expected number of people to be served will be between 300,000 and 500,000.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Improve physical and nutritional health by increasing access to nutritious food that supplies protein and energy to the body increasing the ability to perform physical activity to be measured by the dollar value and quantity of food distributed; improve mental health by providing adequate screening and referral for services to be measured by the number of tests and referrals completed; protect the general public from harm and improve emergency response time by training volunteers to support Emergency services during times of disaster to be measured by number of trainings and certified volunteers; enhance individual economic self sufficiency and divert criminal behavior by providing job training, placement and vocational rehabilitation services to be measured by the number of clients trained and/or job placed; and improve quality of life by feeding and clothing the most vulnerable population of Miami Dade, Broward, Monroe, Lee, Collier, Charlotte, Hendry, Leon and Glades counties.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Work with the state agency to establish a corrective action plan.
