#### 4. Project/Program Description

This project will equip Palm Beach County Fire Rescue vehicles with a NFPA direct source exhaust protection system that works automatically 100% of the time (24/7 365 days) to remove harmful cancer causing emissions and reduce exposures to our whole community (firefighters, citizens, guests, and the environment).

Currently, nine of our municipalities and neighboring counties have installed these systems to provide a safe environment for the living & work areas of fire personnel. This imperative system will capture the cancer causing particulates that no one should be exposed to. This project will meet the NFPA 1500 2018 1.1.5 requirements that state "The Fire Department shall prevent exposure to firefighters and contamination of living and sleeping areas to exhaust emissions".

We are unable to fund this project at this time but we recognize the critical need for this protection for our firefighters so they may enjoy prolonged healthy lives since they do not hesitate to protect us.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

It has been proven that humans face serious health risks from diesel exhaust emission exposures, as the World Health Organization reclassified all diesel exhaust emissions as a Group 1A, or known carcinogen. Fire department staff are required to use NFPA-compliant equipment to protect staff from diesel exhaust exposures. This equipment will offer protection from the diesel exhaust exposures and assist in the lessoning of illnesses related to those exposures.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

These funds will equip Palm Beach County Fire Rescue vehicles with a NFPA direct source exhaust protection system that works automatically 100% of the time (24/7 365 days) to remove harmful cancer causing emissions and reduce exposures to our whole community (firefighters, citizens, guests, and the environment).

#### c. What direct services will be provided to citizens by the appropriation project?

This project will help protect both firefighters and citizens by eliminating the cancer causing particles from our vehicle exhaust. This equipment would provide our fire department staff with the protective equipment which will reduce the incident from potential illnesses and diseases allowing them to be available to provide services for the citizens in need. Further, this provision will assist in increasing the interest of this career choice for young people who are trying to decide if this career choice is for them.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

At-risk firefighters and staff that respond to fire related calls throughout Palm Beach County. According to a 2018 census report, the county had a population of 1,485,941, making it the third-most populous county in the state of Florida and the 25th-most populous county in the United States. The total population is counted because the Palm Beach County Fire Department is responsible for providing all municipalities within the County support for any given emergency. In 2018, PBC Fire Rescue responded to 135,647 calls and currently have 135 Fire Rescue vehicles.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Decreased incidents of exposure to carcinogens by firefighters and staff that will ultimately cause cancer related illnesses and diseases, which will be reviewed by the number of claims through our Occupational Health Clinic.

The standard penalties are adequate.
