#### a. What specific purpose or goal will be achieved by the funds requested?

Voices for Children (Voices) Normalcy Needs Program provides advocacy, case management, age-appropriate referrals, resources, and wrap-around services to foster an abuse-free future for children who have an open and active dependency court case. This program intervenes when other agencies don't have the means to meet the needs of the child and works to ensure the child not only survives but thrives.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The request includes funding for program costs associated with our Normalcy Needs program and include providing advocacy, case management, age-appropriate referrals, resources, and wrap-around services to ensure the child's basic and essential needs is fulfilled. In addition, our need for services have increased and will continue to increase due to COVID-19.

#### c. What direct services will be provided to citizens by the appropriation project?

Voices serves children who have an open and active dependency court case and works directly with the judges, GAL, and/or the CBC staff to provide advocacy, case management, age-appropriate referrals, and wrap-around services to ensure the child's basic and essential need is fulfilled. Voices will fill a need it the other agencies are unable to do so because of lack of funding or other reasons.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target include children ages 0 through 17 who have an open and active dependency court case in the foster care system. More than 400 children are expected to be served.



## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The goal is to ensure that at least 400 children that have an open and active dependency court case will have their basic and essential needs met, with 85% of children or caregiver reporting satisfaction.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to meet deliverables without notification of good reason will result in financial penalties as described in the contract.
