4. Project/Program Description

Metropolitan Ministries is seeking funds to expand an existing campus to support families in Pasco County who are homeless and at risk of becoming homeless. Metropolitan Ministries seeks to add 24 units of transformational housing for homeless families, a childcare center and family support center. The services offered in these buildings will prevent homelessness when possible, stabilize families and empower them to address barriers to self-sufficiency, including low education attainment levels, limited work experience, lack of access to childcare and transportation, poor credit, and past evictions. The facilities' services will reach 15,530 individuals annually. The need for more services directed to assist homeless families gain self-sufficiency or prevent homelessness has increased due to the economic impact of COVID-19. Additionally, before COVID-19, 45% of Pasco residents live paycheck to paycheck and do not have enough funds to meet basic monthly expenses.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Metropolitan Ministries is seeking funds to build critical facilities in Pasco County needed to house and empower homeless families to address barriers to self-sufficiency and prevent homelessness when possible. Metropolitan Ministries will build 24 units of transformational housing for homeless families, a Childcare Center and a Family Support Center on the existing campus along the State Road 19 corridor in Holiday. A total of 60 families annually will benefit from transformational housing, with at least 85% exiting to permanent housing. A total of 350 children from homeless and low-income families will have access to high quality early childcare services and out of school time programming. A total of 5,000 households will receive a service to prevent homelessness.

b. What activities and services will be provided to meet the intended purpose of these funds?

Through the construction of these facilities, 60 homeless households annually will have access to safe housing and wrap-around services leading to self-sufficiency, including case management, employment/education support, housing search and placement, counseling, healthy food, and budgeting; 350 children from homeless or low-income families will have access to quality childcare and out of school time programming; 5,000 low-income Pasco households will have access to a homeless prevention service through the Family Support Center, such as rental assistance, food, or family reunification.

c. What direct services will be provided to citizens by the appropriation project?



The facilities constructed for Miracles for Pasco will provide housing for 24 households daily or 60 households annually who will have access to direct services, including case management, employment/education assistance, trauma/recovery counseling, and healthy food; Early Childcare services for 300 children ages 0-5; out of school time programs for 50 school age children; and homeless prevention services, for 5,000 households. Metropolitan Ministries will leverage partnerships and the generous support of the Pasco community to support the ongoing operating expenses, projected to be approximately \$15 million over the next 10 years to serve 155,300 Pasco county residents.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project is homeless and at-risk of homeless households living in Pasco County. Approximately 15,530 individuals will be served annually: 180 literally homeless individuals in 60 households will be served annually through the transformational housing program; 350 children who are homeless or low-income will be served through the childcare and out of school time program; 15,000 individuals in 5,000 low-income/at-risk of homeless households will be served with homeless prevention resources through the Family Support Center.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

1. At least 85% of a minimum of 60 families will have improved self-sufficiency. Increase on North Carolina Family Assessment Scale (NCFAS-G) from entry to exit or maintain score of 0 on self-sufficiency domain. 2. At least 80% of 60 households will exit to permanent housing. Amount of households exiting to permanent housing destinations. 3. 5,000 households will receive homeless prevention services. Amount of households provided with a homeless prevention service. 4. 300 children will have access to quality early childcare program. Amount of children attending early childcare program. 5. 50 children will have access to quality out of school time programming. Amount of children attending out of school time program.
