#### 4. Project/Program Description

The funds requested in this LFI will be used towards design and construction of an expansion to the WWTF from 1.0 mgd to 1.25 mgd with new advanced standards to wastewater treatment effluent limits. Includes collection system upgrades removing excessive levels of inflow/infiltration to the WWTF facility and disposal improvements. Starke proposes to modify discharge to waters of the state by incorporating actuated valves to stop backflow to WWTF during high river stages and therefore, eliminating pollutant discharge to Alligator Creek. The upgrades to AWT standards will eliminate the discharge of effluent limits that exceed the state and federal standards.

#### a. What specific purpose or goal will be achieved by the funds requested?

WWTF upgrade to meet advanced wastewater treatment (AWT) standards; collection system inflow/infiltration rehabilitation; disposal system upgrades; actuated valves placement at discharge point.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Desigm and Construction of WWTF facility; collection system rehabilitation; discharge point rehabilitation.

#### c. What direct services will be provided to citizens by the appropriation project?

Wastewater system collection, treatment and disposal that meet the state and federal permit limits.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improved surface water discharge to Alligator Creek and surrounding rivers, creeks and springs. The project will protect the public water bodies of the state by eliminating discharge of nitrogen, fecal coliform and other contaminants from WWTF effluent discharge. WWTF upgrades will improve the effluent quality to Advanced Wastewater Treatment (AWT) standards. The project proposes to design and implement actuated valves/monitoring at river stage to keep waters from backing up to WWTF. Automatic closing valves will decrease untreated discharge from entering back to the public water body. Outcomes can be measured by FDEP permits and testing; SJRWMD testing of public water body.
