#### 12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The City of Fort Walton Beach recently permitted the development of a new Liza Jackson Preparatory School (K-8) on City-owned property in the Mar Walt Drive area. This area historically floods during every rain event and effects the operation of neighboring properties, which includes White Wilson Medical Center, Fort Walton Beach Medical Center and The Meridian Long-Term Care Facility. Through the permitting process, the City engaged the neighboring property owners to create a partnership to address the stormwater issue in this area through this project. The City's Golf Club property provides the land required to construct this stormwater facility, which frees up valuable property for the others to expand their operations.

The Clty, in partnership with the property owners and tenants in this area, are supportive of this project.

b. What activities and services will be provided to meet the intended purpose of these funds?

Funding will be used for the planning and design for a new stormwater management facility in the Mar Walt Drive area.

c. What direct services will be provided to citizens by the appropriation project?

The citizens would benefit from a reduction in flooding and improved water quality into Choctawhatchee Bay from stormwater runoff.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improve stormwater management: The Mar Walt Drive area currently experiences flooding during normal rain events, and the City has taken proactive measures to reduce the frequency of these events. This will allow for the creation of a regional stormwater management facility to better control the stormwater runoff and increase the redevelopment potential of the area.

Improve surface water quality: Improve water quality in Choctawhatchee Bay.

Economic development: This project is a public-private partnership to allow for the construction of a new school and expansion of medical facilities in the area.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Revocation or repayment of funding.
