a. What specific purpose or goal will be achieved by the funds requested?

The goal is to eradicate preventable metabolic disorder mainly Chronic Kidney disease/End stage renal disease. With a purpose to serve the underserved, chronically ill, & seniors to manage underlying causes i.e. diabetes, obesity, cardio, mental health, etc. And with time achieve initiatives preventable and reoccurring cultures, healthy lifestyle habits in our underserved communities in the state.

b. What activities and services will be provided to meet the intended purpose of these funds?

Initiation, training and roll out of the service programs called Chronic Care Management, Remote patient monitoring and Continuous glucose monitoring will significantly decrease mortality and hospital ER visits. Covid -19 for this population is already at a disadvantage and vulnerability to mortality of Covid-19. Training of staff and clients is paramount for healthcare culture change.

c. What direct services will be provided to citizens by the appropriation project?

Our program will provide COVID monitoring testing equipment kits initially. And for the sake of social distancing the services will supply monitoring equipment to allow 24 hour access and review to vitals as well. For example a 4G Facetime telehealth monitor, Blood Pressure Machine, Glucose Monitor, Temperature gauge, Pulse Oximeter, ECG/EKG monitor and digital scale.

d. Who is the target population served by this project? How many individuals are expected to be served?

The Elderly, Persons with cardiometabolic disorders, mental health disabilities, Persons with poor physical health, Jobless persons (Particularly Graduate students) economically disadvantaged persons, Homeless with health conditions, developmentally and physically disabled. Our plan is to serve 1,000 or more clients or 250 clients per HBCU Hub.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Our services are measurable and have prevention outcome values established by reputable institutions such as American Heart Association. A specific benefit example is our monitoring services allows 24 hr. digital monitoring access of the clients specific value i.e. blood sugar levels, EKG/ECG, blood oxygen levels, blood pressure, and many other monitoring services depending on the disease states. A client will receive consult telehealth call from Physician, Pharmacist and or Clinical Staff with consult/ training initiated. A case coordinator will verify clients address to ship digital monitoring equipment according to the disease states. Monthly call and review of clients values are graphed, recorded and if abnormalities are identified immediate contacting occurs along with contingencies initiated.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Any acts of fraudulent nonperformance activity is directly reported to the Department of Health authoritative boards. The REACHOUT Project has monitored CMS (Center for Medicare and Medicaid) measurable Electronic Health Records and the audited CMS Chronic Care Management program as a performance measure. Additionally, all parties involved are state licensed through the department of health. Furthermore, the monitoring and reporting is reviewed by a licensed Physician, Pharmacist, RN, Social worker and Attorney prior to submission.
