Reduced duration of standing water in residential areas to reduce spread of water-borne pathogens; the duration of standing water after a rainfall event will be recorded post-construction to measure and verify the level of benefit. Reduction of frequency of roadway inundation; Rainfall will be recorded and compared to any post construction roadway inundation to measure and verify the level of benefit. The project will provide jobs in the engineering and construction industries as required to design, permit and construct improvements; Estimates of staff hours will be required from the design and construction contractors.
