12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Career and job placement activities will lead to youth obtaining industry recognized certificates, improved academic outcomes, increased job readiness skills, placement in a job with a meaningful wage, and reduced involvement in the juvenile justice system and reduced recidivism.

b. What activities and services will be provided to meet the intended purpose of these funds?

Students will engage in learning opportunities that teach workplace readiness, which may include understanding personal qualities and employable traits, self-management skills, team work, professionalism, job-seeking skills, and personal finance. Students will participate in career fairs, mock interviews, job shadowing, as well as engage in mentoring and apprenticeship placements, as appropriate.

c. What direct services will be provided to citizens by the appropriation project?

Students receive guidance, instruction, and support that leads to them successfully securing and maintaining a job in their local community. Services will include instruction in career readiness content, coordination of community resources/agencies that prepare youth for employment and diminish delinquent behavior, and access to job recruiters who will work with potential employers.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target population includes the following: persons with poor mental health, jobless persons, economically disadvantaged persons, at-risk youth, grade school students, high school students, currently or formerly incarcerated persons, and drug offenders in criminal justice.

Funding is expected to serve >400 AMIkids students.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

- 1. Quality Education: Outcome: # of students who receive vocational instruction leading to industry certification. Measure: # of students earning industry certification
- 2. Employment: Outcome: # of eligible students placed in jobs. Measure: Employment verifications and follow up
- 3. Economic Self Sufficiency: Outcome: # of students who earn certificates and # of eligible students placed in a job with a meaningful wage. Measure: Track certificates, job placement and wages earned
- 4. Reduce Recidivism: Outcome: # of students who successfully complete program who do not re-offend for 12 months. Measure:
