12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The requested funds will support FloridaWest Economic Development Alliance's work to serve those underrepresented in rural and urban areas through an innovative community workforce development solution that creates a coalition of education, nonprofits, government and businesses to provide community workforce development and on the job training to individuals with barriers to employment.

b. What activities and services will be provided to meet the intended purpose of these funds?

This initiative is an innovative solution that creates a coalition of education, nonprofits, government and businesses to provide community workforce development and on the job training to individuals with barriers to employment. State funding would allow us to create an additional nighttime Aviation Maintenance Training class. This would allow us to train and certify an additional 24 Aviation Maintenance Technicians per year. Funding would also allow us to stand-up a community-based construction trades course. This course (at least 15 individuals for the pilot course) would include the National Center for Construction Education and Research /NCC ER\ which is the introductory course all construction trades certificate or programs.

c. What direct services will be provided to citizens by the appropriation project?

The average starting salary for those completing the Aviation Maintenance Training Program will be \$53,000, so the total financial footprint through this program will be up to \$1,272,000 annually in economic impact to the community from newly employed individuals. The average starting salary for those completing the Construction Trades course is approximately \$30,000, so the total financial footprint through this program will be up to \$2,250,000 annually in economic impact to the community for newly employed individuals. Therefore, the total financial footprint through both of these programs will be up to \$3,522,000 annually economic impact to the community for newly employed individuals.

d. Who is the target population served by this project? How many individuals are expected to be served?

Jobless person, economically disadvantaged persons, at-risk youth, homeless, high school students, university/college students, currently or formerly incarcerated persons. Between the two programs, we anticipate to serve over 100 individuals.

Outcome: Provision of soft skills education (e.g. resume building). Provision of hard skills education (e.g. hands on training, mentoring). Certifications received by the individual participants. Measurement: Number of industry level certifications received by individuals in the program. Outcome: Enhanced job opportunities available through both programs. Both programs are in high demand. Measurement: Number of participants receiving employment increases through the program. Outcome: Individual's ability to provide income to manage/maintain a household to purchase day-to-day necessities, goods and services for him/her self and family. Measurement: Increase in individual participants Personal annual income.
