This project will control flooding and other hazards associated with stormwater surges and will reduce pollutant loading into Biscayne Bay. Project as designed will reduce loading for total suspended solids, total nitrogen, total phosphorus, and other contaminants that may enter into a designated priority surface water for the Water Management District, by treating 0.5 inches of stormwater runoff.

**b. What activities and services will be provided to meet the intended purpose of these funds?**

This project as designed will control flooding and other hazards associated with stormwater surges while also mitigating the environmental hazards associated with stormwater runoff.

**c. What direct services will be provided to citizens by the appropriation project?**

This project will control flooding and other hazards associated with stormwater surges.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

The residents and businesses within the Village of Palmetto Bay will benefit from this project through a reduced risk of flooding and the associated environmental hazards contained in stormwater runoff. An additional benefit is a reduction in the FEMA Community Rating System (CRS) which will directly impact insurance premiums and should result in a reduction in those rates. Approximately 2/3 of the residents, or 18,000 people will be directly impacted.

Stormwater treatment standards for Sub-Basin 61 are designed to treat 0.5 inches of stormwater runoff. Project as designed will reduce loading for total suspended solids, total nitrogen, total phosphorus, and other contaminants. The Village intends to inspect outfalls annually and to document number of residential complaints reported in regard to flooding and hazardous conditions that may propose a threat to public health, safety, property and the environment.
