This ecological waterfront park restoration project will increase educational and recreational opportunities for all citizens and involves the restoration of Lake Wyman/Rutherford Waterfront Park to include: restoration of wetland resources with the creation of mangrove habitat, removal of invasive, non-native material and the creation of a coastal hammock with educational walking path, restoration and enhancement of an educational canoe/kayak trail system, construction of a fishing/observation pier, and repair and construction of new educational boardwalks.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The City of Boca Raton is seeking funding assistance for the construction of the ecological Lake Wyman/Rutherford Park Restoration project. This project is part of a multi-year, City-wide effort to redevelop its waterfront parks and ecosystems to increase recreational and educational opportunities, increase environmental benefits, and increase access to the waterfront. The project will benefit local residents, visitors, and businesses, in addition to the environmental benefits.

b. What activities and services will be provided to meet the intended purpose of these funds?

The project entails the restoration of wetland resources and the creation of mangrove habitat, the removal of highly invasive, non-native vegetation, the creation of a coastal hammock with educational walking path, the restoration and enhancement of an educational canoe/kayak system, the construction of an observation pier, and the repair and construction of new educational boardwalks. These activities will directly support the overall goal of increasing recreational and educational opportunities in the City of Boca Raton while at the same time benefiting local, ecologically sensitive waterways.

c. What direct services will be provided to citizens by the appropriation project?

This project will turn an underutilized park that is primarily overgrown with predominantly non-native and invasive vegetation, into a beautiful natural area that provides citizens with a myriad of educational and recreational opportunities. Citizens will have direct access to all of the waterfront park's features, including an educational canoe/kayak trail, recreational fishing, safe boardwalks and walking trails through restored natural south-Florida habitats, and opportunities to learn about the natural environment of Boca Raton.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population to be served by this project includes all citizens of the City of Boca Raton, along with tourists and other visitors. The City has an estimated population of approximately 100,000 residents, with many more tourists and visitors. The park is expected to also provide an outlet for COVID-19 recreational opportunity that is safe, and is also expected to particularly benefit local school children.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The construction of this project will benefit all citizens, who will have complete access to the waterfront park. The increased recreational and educational opportunities accrued from this project will lead to improvements to quality-of-life and life enjoyment, and will be measured by documentation of usage. Additionally, the project is expected to have positive environmental benefits by the creation of new mangrove habitats which will be home to many highly sought recreational fish species, with those same mangrove habitats serving to also help reduce pollutants and help protect the shoreline from severe storm events and sea-level-rise.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Reduced levels of reimbursement may be considered if deliverables are not achieved as proposed.
