12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

When families in our community are struggling to feed themselves, and keep a roof over their heads, Second Harvest's Feeding Rural Florida program services help them regain stability and self-sufficiency. Second Harvest works with 149 hunger relief partners to get nutritious food to people in need when they need it most. As low-income families are provided food, they have additional money to spend for other purposes like rent, childcare, medical bills and utilities.

b. What activities and services will be provided to meet the intended purpose of these funds?

Funding will support the purchase and distribution of about 400,000 pounds of healthy food to people from rural Florida counties. Second Harvest has access to low-cost food through its partnership with the nationally respected charity Feeding America.

c. What direct services will be provided to citizens by the appropriation project?

Funding will be utilized to provide nutritious food at no cost to Floridians in the Big Bend region.

d. Who is the target population served by this project? How many individuals are expected to be served?

Hunger affects people from all walks of life. Working families, retired seniors on fixed incomes, grandparents with custody of grandchildren, the chronically ill and the disabled all turn to Second Harvest for help in emergencies or as part of their regular meal planning. One "bad month" can be enough to push a household into food insecurity. Lay-offs at work, unexpected car trouble, or an accident on the job can suddenly force a family to choose between buying food and paying bills.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected program outcomes include:

- 1. Distribution of enough nutritious food for over 333,000 meals. (Meals = pounds of food divided by 1.2)
- 2. A cost savings of \$696,000 for rural communities. (Savings = pounds of food multiplied by the audited wholesale valuation of \$1.74.)
- 3. A cost savings of over \$1 million for recipients from poverty-level and low-income households. (Savings = number of no-cost meals multiplied by the average retail cost per meal in the Big Bend of \$3.21.)
- 4. A healthcare cost savings of over \$1.2 million for food insecure people. (According to the CDC, the average food insecure Floridian pays \$2,046 more for healthcare annually. Feeding Rural Florida will prevent food insecurity for 600 people.)
- f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Second Harvest of the Big Bend must submit evidence of performance before drawing down the funds.

- * Proposed reimbursement is based on the projected average cost of distribution and is paid after the distribution is made.
- * The State has the authority to withhold payment for failure to perform.
