The Bay Youth Summer Work Foundation made a deliberate effort to reach out to socially marginalized students whose family's income is below the national poverty level for a family of four. Findings of the statistics baseline survey provided evidence of the percentage of Bay County students living in households below the national poverty level standard.

The Bay Youth Summer Work Foundation will focus on the job training acumen as its core value of metrics measurements and will strive to offer year-round part-time jobs beginning in 2022 on a student by student basis for students working or attending virtual learning environments. The monthly gross earning salary paid during the student's internship averages \$2,000 per student.

c. What direct services will be provided to citizens by the appropriation project?

The needs of the community have grown exponentially since 2017 and have risen above the staged support of local sponsors whose average contribution is \$200 per business. Administrative operational funds are required for placing participants in locations with their prospective employers who accept students for 4-6 week periods in rotating shifts. The Bay Youth Summer Work Foundation will also help in increasing student's awareness of the technical industrial opportunities that exist in Bay County and will serve as a conduit to Haney Technical Center as it provides support to students and counseling in career profiles to help overcome educational hurdles.

d. Who is the target population served by this project? How many individuals are expected to be served?

The Bay Youth Summer Work Foundation will also help in increasing students' awareness of the technical industrial opportunities that exist in Bay County and to serve as a conduit to Haney Technical Center as it provides support to students and counseling in career profiles to help overcome educational hurdles. The foundation will engage students and businesses in a healthy, productive manner.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The documented outputs lead evaluators to the conclusion that the collaboration between the Bay Youth Summer Work Foundation's business partners, academic institutions, and community support serves as a catalyst to expand the entire program. Management and coordination reporting work evaluations at the end of each student apprenticeship. In the absence of data documenting progress made in relation to the results of the baseline study, parents and business supporters gave extraordinary testimonials of beneficiaries documenting the project's impact. The project has brought about change, as it added the career choice perspective to the adage of, I will figure out what I want to do when I graduate college.
