The request is to combine remaining funds in the amount of \$2,500,000 previously appropriated in Fiscal Year 2019-2020 with remaining funds in the amount of \$3,250,000 previously appropriated in FY 2020-2021 for the Watson Bayou project for the Bay County Board of County Commissioners. No new funds are requested. By combining the remaining funds from the previous projects, the recipient can save significant funds by having a single mobilization and demobilization of dredging equipment, vessels, and excavation equipment needed to complete the construction and dredging in all parts of the Watson Bayou as previously approved and funded.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The request seeks to combine remaining funds resulting from costs savings of previously legislatively appropriated projects in this same water basin by the same recipient (Bay County Board of County Commissioners). There are no new funds included in this request. By combining the remaining funds from the previous projects, the recipient can save significant funds by having a single mobilization and demobilization of dredging equipment, vessels, and excavation equipment needed to complete the construction and dredging in the Watson Bayou basin. The project will increase and improve economic activity, create immediate job opportunities, and improve transportation conditions by expanding capabilities of the Watson Bayou basin to accommodate the construction, launching, outfitting, and sea trials of the United States Coast Guard Cutters which are under construction in the basin.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Construction, dredging, and spoil disposal. Watson Bayou improvements will enable governmental, industrial, and commercial water dependent activities. The United States Coast Guard Offshore Patrol Cutters will transport from the Panama City Industrial Complex through Watson Bayou to/from St Andrews Bay, the Gulf Intracoastal Waterway, and the Gulf of Mexico.

#### c. What direct services will be provided to citizens by the appropriation project?

Will provide for additional jobs and stimulate economic activity in an industrial sector that typically generates indirect jobs in support of the long-term direct jobs which are created and maintained. The University of West Florida Haas Center conducted a Financial Impact Analysis of the work to be performed and concluded that 900 direct jobs and between 3,500-500 indirect jobs will be created for up to 20 years of the performance of the manufacturing contract. Legislative assistance supports improved competitiveness of the USCG contract when it is advertised for re-compete from shipyards across the country.



#### d. Who is the target population served by this project? How many individuals are expected to be served?

The State of Florida in general and the multi-county population whose employees commute daily to the shipyard in Panama City and Bay County. Maintaining and creating hundreds of direct and indirect jobs in the multi-county region which support these manufacturing projects will be served. The citizens of Bay, Gulf, Washington, Jackson, Calhoun, and Walton counties are the primary counties in which targeted direct-hire employees live.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Regional job creation and economic activity. The measured outcome includes deepening the Watson Bayou basin in support of movements of the 300+ foot length of the United States Coast Guard Offshore Patrol Cutter.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The county is willing to impose construction performance bond requirements.

Improvements are in the sovereign submerged lands of the State of Florida and the adjacent shoreline owned by Eastern Shipbuilding Group, some of which is subject to a long-term lease with the City of Panama City.
