#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

To support children & youth who have one/both, parents incarcerated & their caregivers in South Florida through educational enrichment, career exploration & job readiness skills, social-emotional skills & positive mentoring. Data shows there are about 15,000 children in MDC with an incarcerated parent(s). With its current resources, SVC has provided services to over 1,000 youth breaking the cycle of generational incarceration for two generations.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

SVC supports children of incarcerated parents and their caregivers by providing them with educational enrichment, career exploration, job readiness skills, social-emotional skills & positive mentoring.

#### c. What direct services will be provided to citizens by the appropriation project?

Afterschool and out of school activities that develop and build skills for future jobs, peer group activities, counseling, career training, including certificate programs for graduating students, enrichment field trips, coaching and mentoring, free summer and out of school camps.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

SVC expects to serve between 101 and 200 participants per year. Participants include students in grade school, middle school, high school, and those attending vocational or other post secondary training.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will



#### be measured?

80% of participants will show progress towards identification of career interests, establish a proposed career path, two job-related skills, or complete at least one age appropriate job/career related training. Participant will undergo a full assessment, including academic level at onset of participation and at the end of each academic year. For each grading period Program Staff will review academic progress, grades, and will monitor SVC trainings and activities in.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

#### for failing to meet deliverables or performance measures provided for the contract?

SVC will implement a workplan and monitor progress towards deliverables achievement on a monthly basis. If it fails to meet deliverables two months in a row, it will analyze monitoring data to establish the reason, will discuss it with the Contract Officer and will implement a corrective action plan to get back on track. If it still fails to meet deliverables or performance measures, SVC will pay a penalty equivalent to the cost per client for the number of clients or deliverables not met.
