The Ideal 1000 project was shallow water storage on 915 acres of a 978 acre parcel. It required minimal capital costs of \$306,000 which was used to improve the perimeter berm in several places; add one internal water control structure; monitoring equipment and soil remediation. A temporary pump station provided by the landowner was used to draw water from a regional storm water canal that feeds directly into C-24. The project sits adjacent to the C-24 canal and which is in the St Lucie River Basin Action Management Plan "BMAP" and operated from May 2015 until May 2018.
