4. Project/Program Description

Common Threads (CT) seeks to grow our evidence-based nutrition education for school health and wellness programs throughout the State of Florida. This project is projected to reach 5,521 Floridians (approximately 3,500 students and 1,800 teachers and parents) with nutrition and healthy cooking education. Our programs include: Educator Professional Developments (18 live classes; 6 virtual) Small Bites (720 live classes; 320 virtual), Cooking Skills and World Cuisine (300 live classes), Family Cooking Classes (20 live classes), Parent Workshops (12 live classes), Grocery Store Tours (5 live classes), Virtual Cooking Classes (25 virtual), On-Demand Programming (unlimited), Teacher Resources (estimated 500 Teachers).

Common Threads received support in the amount of \$416,700 in May 2020, \$527,000 in 2021 through the Payroll Protection Program and the support was used to partially cover salary expenses to eliminate lay-offs and furloughs in our FY20. Additionally we received an Employee Retention Credit of \$97,000 in 2021 related to 2020.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Our goal will be to improve the health and wellness of under-served communities. Our output goals for the 2022-2023 program year are: 1) to serve at least 5,521 students, parents/guardians, and teachers with nutrition and healthy cooking education and provide resources and; 2) for participants to receive up to 45,953 hours of programming and to cook and consume up to 34,702 healthy meals and snacks.

b. What activities and services will be provided to meet the intended purpose of these funds?

Common Threads' approach to nutrition education is unique, as it is intended to improve multiple elements of community health and wellness by engaging children, families, teachers, and other adult role models in our hands-on cooking and nutrition education classes. This comprehensive approach ensures children and families are supported in making healthy choices across environments-where they live, learn, work, play and shop-thus bolstering and helping to sustain its positive impact.

c. What direct services will be provided to citizens by the appropriation project?



We will provide Educator Professional Development (18 live classes, 6 virtual) to help educators learn concepts to integrate nutrition into core content areas. Our Small Bites program (720 live classes, 40 virtual) will provide nutrition education reinforcing core academic concepts through grade level aligned lessons and healthy snack recipes. Cooking Skills and World Cuisine (300 live classes) and Virtual Cooking Classes (25 virtual) teaches students how to cook culturally diverse, affordable, and healthy dinners. Our Family Cooking Classes (20 live classes) teach families how to cook together and incorporate healthy habits at home while maintaining their existing cultural traditions. Parent Workshops (12 live classes) and Grocery Store Tours (5 live classes) teach caregivers how to shop for and prepare healthy meals on a budget. Lastly On-Demand and Teacher Resources are available State-wide at no charge for teachers to access educational materials.

d. Who is the target population served by this project? How many individuals are expected to be served?

We provide programs in schools and with community-based organizations in communities where at least 80% of children participate in the free- or reduced-priced school lunch program. Our youth programming focuses on grades preK-8th. We also provide programming to parents/caregivers and educators of these students. In total, we expect to serve approximately 3,500 students and 1,800 adults.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The expected benefits or outcomes are: participants will increase their liking for vegetables; participants will improve their self-efficacy for food preparation; participants will increase their nutrition knowledge; participants will self-report increased consumption of vegetables and whole grains; and participants will increase the frequency of helping to cook at home and communication with their family about healthy eating. We measure these outcomes in a variety of ways through our dedicated research and development team: 1) pre- and post-surveys; 2) anecdotal or self-reported communication; and 3) class observations.
