12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The City collects and transfers approximately 1.5 million gallons of wastewater per day to the City of St. Petersburg for treatment. The City of Treasure Island owns and operates the wastewater collection system which has over 122,781 linear feet of predominantly Vitrified Clay Pipes (VCP). The wastewater collection system is currently 20% lined. Lining of the VCP will reduce Inflow and Infiltration (I&I) into the wastewater collection system.

b. What activities and services will be provided to meet the intended purpose of these funds?

Design and specifications development to include construction administrative services. Construction activities associated with lining wastewater collection system.

c. What direct services will be provided to citizens by the appropriation project?

The direct services to be provided is a more reliable and effective wastewater collection system with the pipes being lined to avoid excessive liquids from the I&I. The wastewater collection system is predominantly made of Vitrified Clay Pipes (VCP). The collection system has cracks and has areas that allow for Inflow and Infiltration (I&I). By lining the collection system pipes will significantly reduce I&I. This will decrease the amount of wastewater that is sent to St. Petersburg for treatment, thereby, reducing costs associated with treatment.

d. Who is the target population served by this project? How many individuals are expected to be served?

The project benefits the entire City of Treasure Island community, including approximately 6,700 City residents, hundreds of seasonal residents, over 20,000 visitors each year, hundreds of businesses and recreational services.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?



The purpose of these funds are to line the City's wastewater collection system. The expected benefits of the project are decreased inflow and infiltration, which negatively impacts rate payers and increases the likelihood of sanitary sewer overflows. This outcome can be measured by inflow and infiltration testing and wastewater flow reductions.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The City of Treasure Island is diligent in ensuring that all project deliverables are met within required time frames. If an issue is anticipated, the City will coordinate with the Department in advance to make any necessary adjustments.
