### 4. Project/Program Description

Mental Health First Aid (MHFA) is identified in Substance Abuse and Mental Health Services Administration's (SAMHSA) National Registry of evidence based programs. Often, we are unsure about whether to approach someone who appears upset and feel helpless about how to be of assistance. MHFA teaches a basic 5-step intervention that empowers the participants to directly confront someone who is showing signs and symptoms of distress and guide them to the help they need. The requested funds will allow Alpert JFS to provide Mental Health First Aid trainings with a focus on high-risk communities. Alpert Jewish Family Service will send 8 individuals to a national training to be become certified as an Mental Health First Aid Instructors by The National Council for Wellbeing. These instructors will provide the 7.5 hour training to 700 new community members and professionals.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Alpert Jewish Family Service will add 8 new nationally certified instructors and broaden its reach to a wider population with a focus on vulnerable communities. These 8 new instructors will train an additional 700 first responders, professionals, and concerned citizens to recognize signs, symptoms, and behavior changes in individuals developing or suffering a mental illness and/or substance use disorder.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Requested funds will allow Alpert Jewish Family Service to provide Mental Health First Aid trainings with a focus on highrisk communities. Alpert Jewish Family Service will send 8 individuals to a national training to be become certified as an Mental Health First Aid Instructors by The National Council for Wellbeing. These instructors will provide the 7.5 hour training to 700 new community members and professionals.

#### c. What direct services will be provided to citizens by the appropriation project?

The direct service is teaching the 7.5 hour Mental Health First Aid classes thoughout the county/state. It is the intent to have Mental Health First Aid become as common place as CPR and First Aid. By learning how to approach a person experiencing a mental health crisis, lives will be saved.

#### d. Who is the target population served by this project? How many individuals are expected to be served?



MHFA teaches a basic 5-step intervention that empowers ordinary citizens to directly confront someone who is showing signs and symptoms of distress and guide them to the help they need. The population served will be the general population, including education professionals, medical personnel, veterans, ordinary citizens, first responders, and community leaders, among others. With the requested funds, we are expected to serve an additional 700 individuals.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

The expected outcome or benefit will be to improve mental health. MHFA teaches a basic 5-step intervention that empowers the participants how to appropriately support someone who might be experiencing a crisis or developing a mental illness and/or substance use disorder and connect them to the help they need. Opinion quiz is given to participants at the beginning of the class. This opinion quiz measures participants' knowledge at the beginning of the session compared to the end. All participants take a self-graded test at the end of the session. Surveys of class participants will be administered.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If we fail to deliver services as described in this application and/or the contract with DCF, we will negotiate return of funds.
