Activities will include: \* healthy peer and adult relationships. \* small group opportunities that allow youth to develop a sense of emotional safety, peer support, trust and transparency and leverage youth choice and voice. \*Implementing a prevention program and activities that are developmentally responsive and address all forms of substance use.

#### c. What direct services will be provided to citizens by the appropriation project?

Florida Boys & Girls Clubs work with all youth, but specializes in working with youth considered to be highly at-risk, those youth who are no longer simply at-risk but already immersed in their risk behaviors. BGC afterschool programs provide guidance, care, evidence-based practice and resources that keep young people in school and out of trouble.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Florida at-risk youths grades K - 12 attending the Boys & Girls Clubs during out of school time, families and surrounding communities. At least 8,000 youths will be served with this project.

The expected outcome of this project is for every young person should be equipped with the knowledge, skills, behaviors, and attitudes to prevent opioid and prescription drug abuse.
