12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The mission of the State funding initiative is to support research to identify a cure & vaccine for AIDS. Since FL currently has the highest rate of new HIV infections in the Nation, the creation of strategies to prevent/cure HIV infection will significantly impact the health needs of FL. Funds will support a pilot grant program. A prior pilot award led to a strategy to cure HIV and efforts are underway to translate this into human studies. Pilots have led to a high level of new federal grants.

b. What activities and services will be provided to meet the intended purpose of these funds?

Support innovative research leading to a cure for HIV/AIDS and AIDS vaccine developments. State funds will be spent on pilot grant projects to allow researchers to develop innovative lines of research and be more competitive for federal grants. Funds also support a research unit at Jackson Memorial that promotes inclusion of underrepresented minorities in cutting edge research and clinical trials.

c. What direct services will be provided to citizens by the appropriation project?

Funding supports a research Unit at Jackson Medical Hospital which facilitates inclusion of underrepresented individuals in clinical research studies that provide access to cutting edge therapies.

d. Who is the target population served by this project? How many individuals are expected to be served?

HIV/AIDS infected population in Florida. Over 800 individuals are expected to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project will look to improve healthcare outcomes for the community, while increasing patient enrollment for clinical studies and providing greater accessibility to innovative medications and therapies. Pilot awards provide an opportunity for researchers to explore innovative strategies towards developing a cure and vaccine for HIV/AIDS.
