12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funding will be used to support child grief support service programming offered by Valerie's House. All programmatic elements are offered for free and include grief support groups, individual grief counseling, in-school grief support, mentoring, and financial crisis support. Our goal is to continue to meet the growing needs of the community by supporting every grieving child enrolled in Valerie's House Services while helping to reduce the stigma within our communities associated with grief.

b. What activities and services will be provided to meet the intended purpose of these funds?

Valerie's House will continue to network with local schools and children's organizations to ensure a continuous flow of referrals. Staff will facilitate grief support groups, train volunteer mentors, and assess quality of services in order to recommend improvements. On-staff grief counselors will schedule sessions with grieving children who have been identified as in-need of individual services.

c. What direct services will be provided to citizens by the appropriation project?

Valerie's House will provide FREE grief support services to bereaved children and their caregivers. These services include grief support groups, mentoring, individual grief counseling, financial crisis support, and in-school support services. We also provide grief awareness training and outreach to local schools and medical facilities.

d. Who is the target population served by this project? How many individuals are expected to be served?

Valerie's House serves children ages 4-19 who have experienced the death of a parent or sibling. Nearly 70% of families served meet the federal guidelines for low-income or poverty level. We expect to serve 1,200 grieving children and their caregivers in 2022.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

We expect that 75%+ children enrolled for Valerie's House services will demonstrate progress through their grief journey within their first 6 months of receiving services. Valerie's House uses observation by mental health professionals, case notes, caregiver surveys, and self-reported surveys to measure outcomes. Apricot Software is used to compile and report data.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Should Valerie's House fail to meet deliverables or performance measures, we will conduct an internal audit using an independent consultant to determine what programming and reporting improvements need to be implemented to ensure that we meet future requirements.
