The Senior Center is a hub and gathering place for community. We offer multiple and varied programs and activities that address all six dimensions of wellness:

Physical • Intellectual

• Emotional • Occupational/financial

Spiritual • Community/social

The Senior Center is a hub and gathering place for community. We offer multiple and varied programs and activities that address all six dimensions of wellness as stated above.

Numerous clubs and social events provide seniors with opportunities to stay connected, feel valued and face lifechanging events together, such as sharing transitions into retirement or the loss of a loved one—all in a safe and supportive environment.

The educational classes and life-long learning that takes place at the Senior Center helps keep participants alert, engaged and mentally active. In addition, the Senior Center offers food pantry assistance, a community referral database (where older adults can easily connect with other resources available to them), the Gulfport Extended Minibus Services (GEMS provides transportation to seniors for medical visits, events and activities) and the Sr Center's Reassurance Program (providing daily check up calls to older adults who have been referred to the program)

c. What direct services will be provided to citizens by the appropriation project?

The Senior Center also serves as a clearinghouse for older adults to receive community resources and social services that help them maintain their independence and quality of life. Community resources available at the Senior Center include:

SHINE (Médicare assistance); AARP Driver Safety Program; Meals on Wheels; Community Law Program; Gulf Coast Legal Services; and the Lion's Club Vision Program.

d. Who is the target population served by this project? How many individuals are expected to be served?

Individuals 55 and over and those with disabilities.

At present the Center has 5,348 registered members.
