The recent passage of SB 80 in FY 2021-22 recognized the importance of Foster Youth Voice with a mandate for the child to participate in Multidisciplinary Team Meetings in which placement decisions about their lives- housing, education, and sibling separations- will be determined. Foster Youth Voice Training will support the implementation of this statute by educating youth about self-advocacy and child welfare staff to prepare, engage, and debrief youth to avoid further traumatization.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Training youth to use their voices in decisions that impact their lives will enhance their sense of well-being- physical, intellectual, emotional, social and behavioral developmental needs, in accordance with their views, wishes and feelings. Training child welfare staff on youth engagement principles to better prepare and support youth in care.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Coordinate circuit trainings with 17 lead agencies for youth and child welfare staff. Develop an IL App for ongoing youth training and communication. Complete a qualitative survey to assess youths understanding, preparation, and participation in Multidisciplinary Teams.

#### c. What direct services will be provided to citizens by the appropriation project?

Training youth in foster care on self-advocacy and opportunities to use their voice in decisions that impact their lives.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is youth in foster care ages 13 to 17 and child welfare staff. The Foster Youth Voice Project seeks to train 1,000 youth and 1,000 child welfare staff.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Youth's feelings of well-being will be measured in the training pre- and post-test as well as in the qualitative survey. Child welfare staff's understanding of youth engagement principles will be measured in the training pre- and post-test.



f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Performance hold back of 10% if deliverables or performance measures are not met.
