Rather than treating their symptoms with pharmaceutical drugs as is standard practice, Grey Team is able to alleviate their mental and physical suffering caused by Post Traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI), chronic physical pain, poor nutrition, and lifestyle choices, etc., through the use of innovative, cutting-edge scientific tools combined with basic fundamentals. At the conclusion of our program, service members will understand and implement their newfound eating habits, exercise habits, mindfulness training, life skills, and will have bolstered their all-important social support network.

a. What specific purpose or goal will be achieved by the funds requested?

Aid active-duty military and prior-service veterans in developing healthy, sustainable lifestyles. Because these service members face unique trials that come with having dedicated their very lives to our nation, they require innovative, creative solutions to regain and elevate their mental and physical health.

b. What activities and services will be provided to meet the intended purpose of these funds?

Active-duty military service members, reservists, national guardsmen and women, and veterans will receive FREE lifesaving therapies such as Photobiomodulation Therapy (low-level laser), Infrared Detoxification Therapy, Hyperbaric Oxygen Therapy, Electroencephalogram (EEG) Brain Scan, Brain Boost Therapy, Meditation, Trauma Conscious Yoga, Tai-Chi, and other mindfulness therapies.

c. What direct services will be provided to citizens by the appropriation project?

Active-duty military service members, reservists, national guardsmen and women, and veterans will receive life-saving services which includes Photobiomodulation Therapy (low-level laser), Infrared Detoxification Therapy, Hyperbaric Oxygen Therapy, Electroencephalogram (EEG) Brain Scan, Brain Boost Therapy, Meditation, Trauma Conscious Yoga, Tai-Chi, and other mindfulness therapies.

d. Who is the target population served by this project? How many individuals are expected to be served?



Active-duty military service members, reservists, national guardsmen and women, and veterans in Florida who struggle with PTSD, TBI, depression, anxiety, self-imposed isolationism, and other visible and invisible wounds of war/service. Despite receiving numerous applications from veterans who have reported suicidal ideation in their past, Grey Team has never lost a veteran to suicide.

We plan to serve a total of 250 active-duty military service members, reservists, national guardsmen and women, and veterans by 2025.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The overall outcomes of this program are a reduction in the number of Florida veteran suicides, improved physical and mental health, reduction in self-imposed isolation, improved memory and executive function, and feeling more connected to their community.
