Immeasurable benefit of providing a safe evacuation route from the Barrier Island for Bradenton Beach and Longboat Key along SR 789. Benefit of keeping power on during storm events for a tourist-driven area will increase visitors and tourist dollars to the area. The benefit of removing the power lines from the rights-of-way in very limited real estate (barrier island developed in 1957) provides huge opportunities to install stormwater drainage, wider and safer pedestrian and bicycle corridors (some streets do not have sidewalks in the beach community) and will enable a tram trail to connect the main business area of the City to a water-front beach park that consists of 1/3 of the City along the Gulf of Mexico.
