Improved reliability of potable water service and extended infrastructure life.

The Wynmoor region of the City is home to approximately 10,000 residents with a large concentration of elderly and retired residents on fixed incomes.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Benefit: Project will decrease number and frequency of potable water service interruptions and water quality concerns associated with breaks/failures in aging water pipes. Measurement: Records are tracked regarding number and frequency of service line repairs and breaks within the area. including boil water notices.
