#### 4. Project/Program Description

Funding will be used to purchase communications equipment for the City of Homestead's Mobile Command Center (MCC). This request is for equipment and technology upgrades which will allow the City to communicate more effectively locally and regionally during times of crisis, and most importantly, provide the much-needed infrastructure and apparatus, allowing for interoperability communications. The equipment the City needs for the MCC includes: Microwave video receivers, Bgan Mobile satellite terminal, tactical cameras with Microwave link to set up remote situational awareness back to C.P. and ruggedized fiber optic cable. In order to deploy this technology in areas ravaged by disaster, we also intend to use funding for Base-X shelter systems with portable air conditioners to self-support our responding personnel who staff the Mobile Command Center vehicle in virtually any condition or location.

The City was awarded CDBG-CV funds for \$1,012,565 for Housing & Utility Assistance, Meals to Covid-affected individuals, and Small Business Grants. Approx. \$2.1M as sub-recipient of Miami-Dade County to reimburse the City for Covid-related operating expenditures. \$183K through DOJ to cover Covid-related police OT. Approx. \$2.5M in PA funding from FEMA for reimbursement of Covid-related exp. and 2 vaccine claims. \$19,192,087 in ARPA funds which Council is to decide fund use at a later date.

#### a. What specific purpose or goal will be achieved by the funds requested?

#### d. Who is the target population served by this project? How many individuals are expected to be served?



The target population is the residents and visitors of the City of Homestead who are (a) impacted by a critical incidents in which the mobile command post would be utilized as a mobile police operational station, (b) residents/visitors who attend community events in which the command post will be utilized for public crime prevention information sharing. (c) residents/visitors who are required to evacuate their community due to the threat of a hurricane including outlying cities, the command post will act as the mobile police station to coordinate such evacuations with other agencies (Federal/State). The command post will also be "ground zero" for police operations in the event of a large crime scene such as a mass shooting, hostage situation or any situation in which the command center will act as the staging area for law enforcement.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The ability for law enforcement operations to be conducted from within a mobile command post that will act as the staging area for the immediate response of law enforcement to a developing critical situation. The mobile command center will be the base for the coordination of Federal/State agencies that may be assisting in a critical response. The mobile command center will also be utilized to provide educational material/information to residents and visitors during community events from within the City. The information that will be disseminated includes crime prevention information, hurricane preparedness, firearm safety, bike safety, pedestrian safety, etc. The use of the command post during community events also provides the opportunity for residents to actually see the enhanced capabilities of the police department due to Congressional support. The command post will act as the mobile police station to coordinate such evacuations and disaster response with other agencies.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The penalties for non-deliverables or performance would be the withholding of funds.
