The exterior building components are in fair to poor condition based on the facility condition assessment. This will require renovation to the brick and stucco roof, and foundation. The HVAC system was installed in 1991 and is in poor condition with units that are beyond their useful life. The system will be replaced in an effort to achieve humidity control and avoid the need for continued mold removal.	3,477,865
