The funds will be used to provide for the construction of a new fire station on the westside of Lake City and will serve the residents and commerical areas on the westside of Lake City and Columbia County. The primary fire station is located on the eastside of Lake City near the original downtown area located close to the intersection of US 41 and US 90. The new station will support the westside high growth area west of US 90 and I-75. The new station will serve both the citizens of Lake City (pop 12,400) and Columbia County (Pop 74,000) resulting in improved ISO ratings, decreased response times for fire and first responders and improved public safety.
