12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Northeast Florida public school students will receive additional in class instruction by virtue of in school primary healthcare and mental health counselling.

b. What activities and services will be provided to meet the intended purpose of these funds?

Primary healthcare and mental health counselling will be provided in school without the student leaving school for an off site office visit.

c. What direct services will be provided to citizens by the appropriation project?

Real time primary care health and mental health appointments with nurse practitioners or MDs or counsellors without leaving the public school campus.

d. Who is the target population served by this project? How many individuals are expected to be served?

Primary school and high school public school students. 800 plus students will be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The immediate benefit is reduced absenteeism. Long term benefits are expected to include increased GPAs and graduation rates. Additionally, parents and guardians can stay at home or work rather than taking their child to an off site office appointment. The parents or guardians can also be included in the telemedicine appointments virtually. Periodic absenteeism reviews will determine the increased attendance percentage.
