To create a 3,000 sq. ft. Interactive Learning and Education Center (IL&EC) that will change the perspective of Holocaust education for this and future generations. The IL&EC will have the capacity to serve a class of 25 people a time. It will feature 2 survivor hologram mini-theaters, interactive smart tables downloaded with all the information currently online about the Holocaust, and the ability to access all of Spielberg's USC Shoah Foundation's 55,000 testimonies as well as the Holocaust Documentation and Education Center's over 2,200 eyewitness testimonies of Florida Holocaust survivors and their liberators. In addition students, educators, researchers, and the public will be able to access memorabilia, document, and photograph collections through 3-D technology. The IL&EC will also feature a comprehensive 10,000 volume Holocaust library. This IL&EC will offer all who visit a uniquely innovative educational experience when studying the Holocaust.
