### 4. Project/Program Description

North Bay Village is requesting \$500,000 to support the Wastewater Pump Station Improvements Project. The current pump station will be demolished and replaced with a new submersible pump with greater capacity to transmit waste to the County's treatment facility. Converting the current wastewater facility from an above ground building to a below grade, more compact, submersible station will reduce pollution to Biscayne Bay and eliminate odor pollution affecting the surrounding community. This project is consistent with the US EPA Flood Resilience Guide as it protects vulnerable waters by fortifying "water and wastewater utilities to withstand a flooding event, minimize damage and rapidly recover from disruptions" (EPA Flood Resilience Guide).

### a. What specific purpose or goal will be achieved by the funds requested?

The goal of this project is to increase the capacity, efficiency, and operational safety of the Village's wastewater pump station.

### b. What activities and services will be provided to meet the intended purpose of these funds?

The Village's mitigation measures include: (1) installing a new submersible pump station; (2) installing a new wet well and valve vault, and controls; (3) retrofitting the station's force main as necessary, (4) constructing a gravity sewer to accommodate the new submersible station; (5) installing a new portable generator to ensure continuity of operation during power outages; (6) abandon the current above-ground wastewater building; (7) create additional green space that is beneficial in managing stormwater runoff.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?



Outcome (1): Mitigate health and safety risks to the public by replacing the failing pump station and increasing access to green space. Measure (1): Completion of the project and implementation of new monitoring system. Outcome (2): Improve water quality in the environmentally sensitive Biscayne Bay and the Biscayne Aquifer. Measure (2): Reduction or elimination of pump failure and overflow of raw sewage into the Village's streets and, ultimately, through the Village's storm drain system and directly into the Bay.
