### 4. Project/Program Description

The proposed project is intended to begin the process of converting the existing septic systems within the City of Midway to a central sewer collection and treatment system. This will include the installation of new gravity sewer collection lines, pump stations and associated forcemains. Over the years, much of the residential development within the City of Midway has been done without the inclusion of central sewer services. The City of Midway has never owned or operated a sewer collection/treatment system, but has relied on Talquin Electric Cooperative (TEC) to provide those services. TEC has done a great job of providing these services to the commercial/industrial developments, but the residential developments have not been required to include this infrastructure in their costs. The City has communicated with the utility owner to ensure that capacity is or will be made available for the proposed connection.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The City of Midway is located in the Wakulla Springs Basin Management Action Plan (BMAP). As such, it is expected that the nutrient loads discharged from the existing septic systems has an impact to the groundwater and ultimately effects the spring. The proposed project would design and construct a portion of the necessary collection and transmission infrastructure to begin the process of the septic-to-sewer conversion. Not only will this provide for improved groundwater quality, but also higher densities to limit urban sprawl.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The proposed project will design, permit and construction critical sewer collection and transmission infrastructure in unsewered portions of the City of Midway. This infrastructure will allow for some immediate connections, but will also serve as the backbone for future sewer expansions within the City.

#### c. What direct services will be provided to citizens by the appropriation project?

Not only will the citizens of the City of Midway be provided the opportunity to be connected to a central sewer collection and treatment system, but, as a result of such connections, they will benefit from improved groundwater quality as well.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The City ultimately wishes to serve all populated areas within the City where sewer expansion is economically feasible. However, due to funding restrictions it is anticipated that this initial project provide more of the system skeleton that will be expanded to serve those areas in future phases. The current project will serve approximately 100 homes.

A total number of septic-to-sewer conversions can be tracked and reported.
