

**1. Project Title** Northeast Florida Regional Public Safety Training Facility - Phase 2

#### 4. Project/Program Description

With a county population of 92,992 and a regional population of 1.6 million, Nassau County and the Jacksonville MSA is one of the fastest growing MSAs in the Country. This rapid urbanization has resulted in a higher volume of calls for law enforcement and fire/rescue services and also changed the complexity and severity of the situations local public safety personnel face on a day-to-day basis. This trend is expected to continue for the foreseeable future as the northeast Florida region is predicted to grow exponentially over the coming decade. As such, the evolution of the local environment requires we augment our training and development capacities. In response, Nassau County has commenced construction of a regional public safety training facility capable of matching the public safety needs of the citizens of Nassau County and the region. This request is for funding to construct an indoor training facility and classrooms totaling \$5.9m of the \$17.5m project (34% of the total).
