4. Project/Program Description

The City of Apalachicola owns and operates a Wastewater Treatment Facility (WWTF) that was originally placed into service in the 1950s. The plant has undergone several upgrades over the years, but has degraded and outdated process equipment which has resulted in the City being placed under consent order by FDEP for these failing components. The requested funds will be utilized for engineering design and permitting services to address the consent order items and provide the City with a system that meets all federal, state and local requirements. The design will also include a resiliency component to relocate the major system components out of the current flood zone.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The requested funds will be utilized to secure engineering services that will produce design solutions for the impaired components of the existing WWTF. Construction of the facility will satisfy the current consent order as well as provide the City with a fully functioning wastewater treatment facility that will meet all federal, state and local requirements. The facility will also have increased resiliency against future storm events that could cause catastrophic failure.

b. What activities and services will be provided to meet the intended purpose of these funds?

Surveying, engineering, permitting and construction administration services.

c. What direct services will be provided to citizens by the appropriation project?

This project will ensure the public health and safety needs of the citizens are prioritized by having a WWTF that meets Federal, State and Local standards. Additionally, the relocation of the major WWTF components to an outside of a designated flood zone will help to ensure resiliency to waste water discharges during future storm events.

d. Who is the target population served by this project? How many individuals are expected to be served?

Every property owner; residents and business owners in the City of Apalachicola will benefit from this project. In addition, all visitors to the city will also be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The design of a properly functioning waste water plant will ensure residents and businesses are not subject to the potential for system failure. Additionally, surface water quality discharge to the spray field and re-use system quality will be improved which will be a direct benefit to the environment. Lastly, the current consent order will be satisfied. Water quality will be assessed by water quality sampling. Component and structural integrity will be assessed through regular inspections by local and state officials.



f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The City of Apalachicola is currently under a Consent Order with FDEP for degraded and outdated process equipment and structures. The City will work with the contracting agency to implement replacement of process components should funding be made available. Failing to meet deliverables could result in penalties associated with violations of the Consent Order.
