4. Project/Program Description

Sarasota County is in the development stages of constructing a Regional Fire/EMS Training Academy to support multiagency training efforts and to provide educational opportunities for technical fire science and emergency medical services at the secondary education, on-going post-employment, and post-secondary education levels. The training facility would allow students who want to become firefighter/EMTs to attend school, receive their certifications, and get hired by regional departments. The projected total cost is up to \$25,000,000. The County is currently funding \$2,000,000 for site planning in FY21. In FY22, the Sarasota County School District has committed \$5,000,000 and the County plans to fund up to an additional \$18,000,000. This local funding initiative request is for \$2,000,000 that will be used to support the construction of one of the burn buildings on the property.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

This funding will assist in the construction of a Regional Fire/EMS Training Academy to support multi-agency training efforts and to provide educational opportunities for technical fire science and emergency medical services at the secondary education, on-going post-employment, and post-secondary education levels. The training facility would allow students who want to become firefighters/EMTs to attend school, receive their certifications, and get hired by regional departments.

b. What activities and services will be provided to meet the intended purpose of these funds?

This facility will offer educational and training opportunities to high school students, university/college students, and others interested in pursuing a career as a firefighter/EMT, as well as those currently employed by local public safety entities. Specific training activities include fire props and scenarios, search and rescue, trench rescue, confined spaces, EMS, aircraft and marine rescue.

c. What direct services will be provided to citizens by the appropriation project?

This facility will educate, train, and certify emerging firefighter/EMTs and those currently employed with the Sarasota County Fire Department and other regional fire rescue agencies. In turn, these individuals serve the community and offer direct services to the citizens of the community by providing life safety, fire prevention, fire protection, fire suppression, and emergency medical services.

d. Who is the target population served by this project? How many individuals are expected to be served?



The target population includes high school students, university/college students, and technical school students, as well as those currently employed with SCFD and other fire rescue agencies. The project will serve hundreds of individuals and will continue to serve individuals in the target population over many years to come.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The outcome is improved quality of education for firefighter/EMTs. Measures include graduation rates, certification rates for firefighters and EMTs), and the percent of certified graduates that obtain employment within within the field of study within two years of graduation. This outcome will be measured through partnership with the School District. Performance measures are tracked by data relating to graduation rates, certification rates, and employment within the field of study following graduation. Ongoing evaluation of these measures can lead to modifications in training and education curricula to foster improvements.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Sarasota County contract penalties could include: Our standard contract provisions including, liquidated damages, withholding payment and/or termination of contract.
