12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds requested will support the in-hospital education of mothers; the purchase of educational material given to women who deliver at area birthing hospitals; and enrollment in an ongoing educational text-messaging service for followup all with the goal of increasing what parents know about the importance of healthy early brain development in the first three years of life. These tools teach parents that they are key architects of their child's brain development and kindergarten readiness.

b. What activities and services will be provided to meet the intended purpose of these funds?

SCI's partner, ARC Gateway, provides life and work skills training for adults with developmental delays. Assembling, storing and delivering the bags is a contracted job of their day program, generating revenue for them to support their services and providing their clients with meaningful, worthwhile work opportunities. Our contract with ARC ensures the continuation of service and ensures that the project meets the needs of their clients.

c. What direct services will be provided to citizens by the appropriation project?

Direct services provided will be the distribution of a video lesson and take-home learning resources in the hospitals; follow-up coaching for parents with children birth to 3 with partners Healthy Start Coalition, Florida Department of Health in Escambia and Santa Rosa counties, and pediatric clinic sites; an enrollment in Basics Insights educational text messages and follow-up video lessons.

d. Who is the target population served by this project? How many individuals are expected to be served?

New parents, parents of children birth to 3 years old that are at risk for adverse outcomes, pregnant and new mothers.



e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

As of 2020, the kindergarten readiness rate in Escambia County is poor, at 48%. Changing this means helping parents to do more for their children's brain development. By distributing in birthing hospitals, we track the number of bags handed out and scores on survey to gauge parent knowledge before and after the video lesson, ultimately increasing the kindergarten readiness rate in our community. To track effectiveness of the lesson, each bag includes a survey asking 2 questions: On a 1-10 scale, rate your knowledge of how parent talk and interaction fuels brain development before the Brain Bag lesson; now rate it after. Early results show moms on average increase their knowledge of 7 to a 9.5 (through 9.30.21). Ultimately we hope that kindergarten readiness increases, as measured by DOE.
