#### 4. Project/Program Description

Design and construct an Aviation Maintenance Technician School at the Sarasota-Bradenton International Airport to supply the workforce that keeps the industry up and running. The workforce training will be a joint effort. If the construction and equipment is funded by the Legislature, the School District of Manatee County will build an Aviation Maintenance Technician School at SRQ Airport. Manatee Technical College and Suncoast Technical College will provide the workforce training to prepare students for high skill/wage/demand careers as Aviation Maintenance Technicians with Airframe and/or Powerplant ratings from the Federal Aviation Administration. University of South Florida, Sarasota-Bradenton, will provide opportunities for additional certifications in Aviation Business and Aviation Management.

#### 12. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The creation of a world-class Aviation Maintenance Technician School at SRQ, the fastest growing airport in the USA. With an estimated 1,474 openings per year for Aircraft Mechanics and Service Technicians in the State of Florida, the demand for training is high. The Aviation industry was hit hard by the Covid-19 pandemic. Industry reports say more aviation mechanics are retiring than are entering the field. There are over 50 aviation/aerospace employers in this workforce region alone.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

To plan, design, and construct an Aviation Maintenance Technician School to be certified by the Federal Aviation Administration (FAA). Manatee Technical College (Bradenton) and Suncoast Technical College (Sarasota) and the University of South Florida Sarasota-Manatee campus will join forces to prepare students for FAA licenses in aviation maintenance and employment and advanced training in the aviation industry.

#### c. What direct services will be provided to citizens by the appropriation project?

Career certificate workforce training in Aviation Airframe Mechanic and Aviation Powerplant Mechanic. In alignment with FAA Part 147 requirements for Aviation Maintenance Technician Schools, instruction will prepare students for FAA license exams for Aviation Maintenance Technician with Airframe and/or Powerplant ratings. The University of South Florida will provide modules for additional certifications in Management (Aviation Focus), Cybersecurity, Analytics/Big Data, Safety Management, and Logistics and Supply Chain Management.

#### d. Who is the target population served by this project? How many individuals are expected to be served?



Target population is individuals who wish to prepare for a high wage, high demand career as an Aviation Maintenance Technician. While the majority of students are expected to come from Manatee and Sarasota counties, it is anticipated that 10-20% of the students will come from other counties to take advantage of the high quality education being offered. The Aviation Maintenance Technician School will be able to serve 100 or more students per year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

The School Board of Manatee County will construct and open an Aviation Maintenance Technician School (AMTS) at the Sarasota-Bradenton Int'l Airport (SRQ) in partnership with Suncoast Technical College and the University of South Florida Sarasota-Manatee. The expected benefit to the state is a trained workforce pipeline into the targeted aviation industry. Outcomes will be measured in training completions, job placements, and employer feedback.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Return the funds to the State if adequate funding is not obtained to construct, equip, and open the AMT School.

The School Board would construct the facility. The facility would be located at the Sarasota-Bradenton International Airport. Both the School Board and the Airport Authority are state agencies. The two agencies have a signed letter of understanding for a 20-year ground lease with four 5-year renewals.
