This project creates a Sensitive Compartmented Information Facility (SCIF) for use in Daytona State College's Cybersecurity specialization. This facility provides physical, acoustic, and digital protection to allow work with sensitive data as per DoD and NSA guidelines. In addition to the SCIF, this request will fund an upgrade of lab equipment, firewall and servers to the most current technology.

DSC is a recognized Center of Academic Excellence in Cyberdefense by the NSA and DoD, and this request is critical to the continuous delivery of relevant training to our students.

## 12. Program Performance

## a. What specific purpose or goal will be achieved by the funds requested?

To better train students in the areas of cybersecurity and database administration. Information Technology is a high growth sector in one of Florida's targeted industry sectors. According to the DEO labor projections for Fastest Growing Occupations for the period 2020-2028, Information Security Analysts will grow 14.4%, Computer Network Analysts will grow 12.6% and Database Administrators will grow 12.1%.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Provide up to date equipment and facilities for the cybersecurity and database offerings at DSC. The firewall, routers and dedicated Internet connection will ensure a safe isolation from the regular college IT systems, thus enabling the freedom to test and try configurations to implement best practices in cybersecurity and data management. The SCIF will meet all the DoD and NSA security standards and provide an optimal platform for hands-on training in cybersecurity.

#### c. What direct services will be provided to citizens by the appropriation project?

Cybersecurity is critical to national security in the government and private sector. There is a shortage of trained professionals and this project will equip our college with the latest technology to deliver training. Another direct benefit is preparing our students for work in a high wage sector. According to the DEO IT Sector Report, the average wage in the IT sector (\$91,603) is 77% higher than the average annual wage for all industries (\$51,761).

#### d. Who is the target population served by this project? How many individuals are expected to be served?



The target population is composed of individuals from the Volusia/Flagler service area, 18 years of age or older. The program will initially serve over 40 individuals in the first year in database and cybersecurity programs. The program has potential to serve over 200 students when fully implemented.
