12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this request is to support the Adult Literacy League's mission: we empower Central Floridians to be thriving members of our community through literacy and education. We exist to build a literate, and as a result, more healthy, inclusive, productive, and rich community!

b. What activities and services will be provided to meet the intended purpose of these funds?

We will recruit, orient and train volunteers to serve as tutors and instructors to the adult students we serve. We offer more than 20 in-person and online classes for adults in our tri-county service area. We are currently supporting the work of more than 250 pairs (tutors and students). These funds will support our operating costs - rent, technology and staffing.

c. What direct services will be provided to citizens by the appropriation project?

We will provide adults seeking our services with the following: assessment to determine student starting point; the opportunity to be matched with a volunteer tutor; the opportunity to attend appropriate online and in-person supplemental classes.

d. Who is the target population served by this project? How many individuals are expected to be served?

Of the more than 1,000 adults we will serve in 2021, between 80-85% are English Language Learning students - immigrants coming from more than 50 countries, speaking more than 20 different languages. We expect to serve between 25-50 adults.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

One of the most common goals of our adult students is: to enter employment. The majority of our students come to us with the expressed goal of getting a job or getting a better job. This is an outcome that is collected as students self-report or when their tutors report monthly via online monthly tutoring report.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If the Adult Literacy League fails to meet the deliverables or performance measures, an appropriate penalty would be the loss of a percentage (correlated to the percentage of deliverable "failure") of the grant funds.
