4. Project/Program Description

Funds are requested to support the Arc of the Bay's new Empowerment Café and Inkclusion Coffee Shops, which was created through a collaboration with Gulf Coast State College and is run through their college cafeteria. This initiative also acts as an extension of our Certified Culinary Institute, allowing us to train those with developmental and intellectual disabilities in the culinary arts and then place them into immediate employment through the Café where they will work sideby-side with 'typically-abled' peers.14 Culinary Institute Clients will receive their ServSafe Certification and maintain employment through the Empowerment Café and Inklusion Coffee Shops. 6-8 community members will be employed at the Empowerment Café and Inklusion Soffee Shops. Funds will additionally cover the costs of comprehensive training from Culinary Institute Instructors and Food provisions to support needed components for this program's operations.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The ultimate goal of this program is to create a truly integrated and competitive work environment for those with intellectual and developmental disabilities residing in Bay County and surrounding counties. Clients will advance to a culinary career while working side by side with typically-abled peers. Thus reducing erroneous misconceptions and breaking barriers to entry into the workforce for this population.14 Culinary Institute Clients will receive their ServSafe Certification and maintain employment through the Empowerment Café and Inklusion Coffee Shops. 6-8 community members will be employed at the Empowerment Café and Inklusion Coffee Shops. Funds will additionally cover the costs of comprehensive training from Culinary Institute Instructors and Food provisions to support needed components for this program's operations.

b. What activities and services will be provided to meet the intended purpose of these funds?

Funds will support the Empowerment Café. 14 Clients will successfully graduate from our training curriculum and learn the skills needed for culinary based employment in the community. Graduates seek employment through the Empowerment Café, Inkclusion Coffee Shops, and will receive comprehensive and continued career planning and support. Staff hired will be 50/50 those with intellectual and developmental disabilities and those typically-abled to create an inclusive and integrative atmosphere.

c. What direct services will be provided to citizens by the appropriation project?



Clients train and learn directly in a commercial kitchen, learning the appropriate skills needed to graduate with their ServSafe Certification. Clients additionally receive career planning, professional instruction, and a path to employment. This allows clients to obtain and maintain employment, earn a paycheck, pay taxes, and participate in the local economy. Further services to citizens include affordable priced food offered through the café available to college students. Services will additionally extend to employees and students of Gulf Coast State College in the form of affordable catering for meetings and events.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes those with intellectual and developmental disabilities residing in Bay County. We expect to assist 14 clients to obtain employment through the Café and Coffee Shops. Included in our target population is the 2,500 students attending Gulf Coast State College. Many students struggle financially and will experience food insecurities at some point during their educational pursuits. The Café offers meals at discounted rates to students attending GCSC and those who reside in the nearby dormitories. We will additionally serve over 350 faculty and staff through catering services.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The benefits/outcome of this project is multifaceted. It will improve local economy by offering new job opportunities as well as the ability for those with intellectual and developmental disabilities to obtain and maintain realistic work, garner income, pay taxes, and participate in the local economy. It will break barriers to entry and allow those with intellectual and developmental disabilities pursue careers without discrimination or exclusion. College students will access affordable hot meals while interacting with and being served by individuals with intellectual and developmental disabilities. Frequent interactions are proven to help reduce stigma and erroneous misconceptions.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

for failing to meet deliverables or performance measures provided for the contract?

Reduction of funds per activity, allowing 30 days notice to include reduction amount.

The Cafeteria is owned by Gulf Coast State College and will be operated by the Arc of the Bay. There will be no capital funding needs and funds appropriated through this ask would be utilized completely for the program and thus administered through the Arc of the Bay directly to salaries and program related costs. The Cafeteria itself has been donated in-kind, along with rent, utilities, water, and gas, to the Arc of the Bay for this program.
