#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Improve District performance grade by centralizing curriculum resources and incorporating parallel services. Improve access to community resources from the School District and parallel service providers by having one location to go to for parents and students.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Funds will be used for renovation services through a construction company, architectural firm, construction contractors, and vendors providing goods and services. Completion of the renovations will allow for central services to families from the school district and parallel service providers like mental health and early childhood programs. Additional community service events will be available in the auditorium.

#### c. What direct services will be provided to citizens by the appropriation project?

Centralized services for education and additional services related to education within the same building. Support community involvement and engagement with a facility available for events that culturally benefit the community.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Immediate supports to 65 employees through collaborative work environment. Benefits to 6000 students and their families through better services to them and the 450 instructional staff supported by the central office's ability to better collaborate. Additional community services will be provided through parallel services to benefit the families of students. 65,000 citizens will benefit to the community services provided through the auditorium's cultural events.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

The investment of \$4 million will have an immediate \$2,250,000 impact on the economy with salaries/benefits and economic stimulation of the added 21 jobs anticipated from the project (CCIM, Estimating Economic Impact found at https://www.ccim.com/cire-magazine/articles/estimating-economic-impact/).
