4. Project/Program Description

The Flagler Access Center is a collaborative, public-private partnership between Flagler County, Flagler Health+, and SMA Healthcare, Inc. to provide a community-based behavioral health resource to assist adults, adolescents, and children receive behavioral health disorder outpatient treatment. Services include Crisis Triage and Treatment Unit (CTTU), a Crisis Response Team (CRT), Care Coordination, Telehealth capabilities, psychotherapy, and substance abuse/addiction treatment. Funding will support 3 mental health professionals to expand capacity to provide mental health and substance abuse outpatient therapy. The Community Access Point will operate 8 hours a day, Monday through Friday. The Flagler Access Center Therapy will provide prompt mental health intervention, assessment, support, and service connections to Flagler County residents. Access can be facilitated by phone, scheduled appointment or walk-ins.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

A partnership between SMA Healthcare, Flagler County and Flagler Health+ to continue a community-based behavioral health resource assisting Flagler residents in receiving behavioral health disorders outpatient treatment for adults and children/adolescents. Through continued funding these needed resources and therapy services, the number of residents seeking services outside of Flagler County will reduce. It will also reduce the number of Flagler residents dying from suicide, substance abuse, or other related mental health illnesses.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Flagler Access Center Therapy employs three substance abuse/mental health outpatient counselors that provide outpatient treatment services for adults and children/adolescents. By doing so, this project expands the capacity of outpatient substance abuse and mental health treatment, reducing the number of Flagler residents who have to go out of county for treatment services, and saves lives.

c. What direct services will be provided to citizens by the appropriation project?

Direct services are provided by the three counselors including, but are not limited to, the following: Screening/Assessment, individual therapy utilizing evidence-based treatment modalities, treatment planning, treatment plan reviews, and other supportive services.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes at-risk youth, high school students, homeless, jobless persons, incarcerated persons, adult/adolescent drug offenders, elderly persons, victims of crime, persons with poor mental health, and economically disadvantaged persons. The program expects to enroll 200 individuals annually into the outpatient treatment service provided at the Flagler Access Center.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Outcomes include the following for those individuals enrolled in outpatient services: a reduction in at least one of the following in one year post enrollment versus pre-enrollment as evidence by self-report: number of days absent at school/work, number of days in emergency crisis services and hospitalizations for behavioral health emergencies, and days being homeless.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

None proposed, subject to negotiation with the Florida Department of Children and Families.
