a. What specific purpose or goal will be achieved by the funds requested?

The City of Port St. Lucie is requesting funding to install a 24" water main that will provide increased water capacity for the Legacy Distribution Park located in the City's jobs corridor. The State's investment will help to unlock 300 acres of undeveloped land, support the development of 3.2 million square feet of warehouse distribution space, and help to create 1,970 additional jobs in the City's jobs corridor. Provide water distribution system redundancy and enhanced fire protection.

b. What activities and services will be provided to meet the intended purpose of these funds?

The project includes all work associated with the construction of a 24" water main to increase the water capacity for the Legacy Distribution Park at Tradition. The increased water capacity will enable the developers to lease space to industrial, distribution and manufacturing companies that will create jobs for Port St Lucie residents.

c. What direct services will be provided to citizens by the appropriation project?

There are currently three economic development projects in negotiations in the logistics and distribution industry, that would benefit from the proposed 24" water main which will increase water capacity. The State's investment will help to unlock 120 acres, support the development of 2 million square feet of warehouse distribution space, and help create 1,970 new jobs.

d. Who is the target population served by this project? How many individuals are expected to be served?

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The 24" water main will increase water capacity and provide access to 300 acres of land, support the development of 3.2 million square feet of warehouse distribution space and create 1,970 additional jobs in the City's jobs corridor.

The two announced project (FedEx and Cheney Brothers) and two prospective projects (Project Green and Project Apron) will benefit from the increased water capacity. The project benefits will be measured by the amount of capital investment, job creation and average wage.
