### 12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The specific goal of the requested funds is to reduce stress-related health issues and deaths for firefighters by making tactile firefighter altering systems accessible to all fire departments. Firefighters are up to 14-times more likely to die of a heart attack during alarm response because most fire departments use startling audible alerts to dispatch responders. Tactile firefighter altering systems use wearable technology that vibrate to gently alert firefighters and reduce stress during an alert.

b. What activities and services will be provided to meet the intended purpose of these funds?

Outfitting fire stations in the state of Florida with this alerting system to reduce their stress and improve overall health outcomes. Specifically, sourcing & assembling hardware, outfitting stations with hardware, monitoring system efficacy, and providing support while the system is in the fire station.

c. What direct services will be provided to citizens by the appropriation project?

Services will be provided to fire departments and their first responders. Focus on career fire departments since volunteers often work from home while career firefighters all work in the station.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target population is firefighters in Florida State Senate District 8 and District 4. This funding is expected to serve between 400 and 700 firefighters, paramedics, and other first responders who are currently alerted by loud alarms in their station. This equates to 33%-50% of all career firefighters in Florida's 4th and 8th Districts.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improved physical and mental health for the first responders who benefit from the tactile alerting systems. Outcomes will be measured quantitatively and qualitatively with HR monitors and pre-/post-surveys, respectively.

The contracting agency shall be penalized by returning any funds that are not distributed appropriately to the state agency that provided the funds.
